**Read label carefully and obtain special instructions before use. Do not handle until all safety precautions have been read and understood.**

**Handling Precautions:** Harmful if swallowed, inhaled or in contact with skin. Causes mild skin irritation and eye irritation. Suspected of causing genetic defects. May cause damage to the hepatic and alimentary systems. Do not breathe dust. Wear protective gloves and use personal protective equipment as required. Do not eat, drink or smoke when using this product and wash hands thoroughly after handling. Contaminated work clothing should not be allowed out of the workplace and should be washed before reuse. Use only outdoors or in a well-ventilated area.

**First Aid:** If swallowed rinse mouth and do NOT induce vomiting. If skin or hair contact occurs remove contaminated clothing and wash with plenty of soap and running water. If splashed in eyes rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If inhaled remove to fresh air and keep at rest in a position comfortable for breathing. **Disposal:** Preferably dispose of product by use. Otherwise treat the product so that it is no longer toxic and dispose of product and packaging at an approved landfill or other approved facility. Bury bag in a suitable landfill, or if appropriate burn.

**Emergency Response:** Contain any spillage and prevent entry into drains or waterways. Sweep up spilled material and place in suitable containers for later disposal. After pickup complete, wash spill site with plenty of water.

## Directions For Use

**Application:** Mix Selprill Double with dry fertiliser at rates calculated to provide not more than 0.5kg/ha (10g elemental Selenium/ha) annually. Alternatively administer directly to the soil at 0.5kg/ha annually. This provides 12 months selenium supplementation for all grazing livestock. Do not administer directly to animals, and do not graze animals during application. Selprill Double is intended for application to soils only. This product should only be used where low herbage selenium levels are known to occur. If in doubt as to the selenium status of your pasture or livestock, consult Ravensdown.

**Coverage:** Even coverage is advisable. Where spillage occurs, excess granules should be dispersed to avoid ingestion by animals.
